Jersey lawmakers hail Colombia's resolve

WASHINGTON-Two New Jersey congressmen returned from Colombia yesterday con-vinced the leaders of that South American government are committed to winning the war against cocaine traffickers, but they said it is clear the U.S. needs to do

more to help them win the fight. Reps. Frank Guarini (D-14th Dist.) and William Hughes (D-2d Dist.) said they and four other congressmen took part in meetings with Colombian President Virgilio Barco this week to get a first-hand sense of the serious problems in that country, and to underscore U.S. support for the war against

cocaine cartels.

The lawmakers, both members of the House Narcotics Abuse and Control Committee, met with Barco as well as Colombia's defense and justice ministers, the national police director, the attorney general, Colombian presidential candidates and U.S. Ambassador Thomas McNamara.

Both said President Bush's plan to attend the Feb. 15 drug summit with leaders of the Andean nations in Cartagena, Colombia, is extremely important from symbolic and substantive points of

Guarini said he found Barco "resolute, determined...and un-wavering in his commitment" to

win the war, and to save the Colombian democracy that is under attack.

But Guarini said it is clear that the U.S. must provide Colom-bia with more military and communications equipment, and work to stop the export from the U.S. of assault rifles used by the "narcot-ics terrorists." He said the U.S. also must take steps to improve money-laundering enforcement here and get other nations to do the same

He also said Barco and other Colombian officials believe the U.S. must act more vigorously to stop the diversion of chemicals from this country that are used to produce cocaine in Colombia.

Hughes, in addition, said he came away with the sense that the U.S. must find a way of helping Colombian officials protect their families, who have been threatened and in some cases killed by the cocaine kingpins. He said a program could be set up to bring some family members of key officials to the U.S. for periods of

Hughes said there is a strong resolve and a great deal of courage apparent among Barco and other Colombian leaders, but he added there is also some "despair, frustration and apprehension" within the society. He said there are a lot of people giving up, but emphasized that Barco is clearly

The American advisory also came just six days before the first anniversary of the terrorist attack that blew up Pan Am Flight 103 over Lockerbie,

Scotland, killing all 259 aboard as well as 11 people on the ground. In the ensuing investigation, it was revealed that U.S. authorities had received warnings about the possibility of a terrorist attack but had not made them public, believing they were not necessarily reliable and might unduly

This time, the U.S. government derins time, the U.S. government de-cided to issue a public advisory at the same time it began briefing foreign governments about such a threat, a de-partment official said.

A brief statement issued by the de-partment cited "recent reports of movement of Middle Eastern terrorists in Western Europe" and suggested "terin western Europe and suggested ter-rorists may be planning near-term at-tacks against a variety of targets, pos-sibly including U.S. interests."

attacks might occur, but added: "If credible, specific information or a threat to the public is received, the Department of State will provide additional information for travelers and other concerned parties."

In the case of Pan Am 103, "we warned some government officials and left the public naked. This time it appears we're not going to get caught in that way."

"The operation to locate Rodriguez Gacha was an intelligence operation of great care," Casadiego said in a live radio broadcast with the Caracol

Authorities say Rodriguez Gacha and Escobar masterminded the Dec. 8 bombing of the federal investigative police headquarters in downtown Bogota. The blast, which left a huge crater, killed 63 peo-ple and injured more than 800.

The bombing was the most deadly during the crackdown on traffickers, who have mounted dozens of attacks to retaliate the extradition of 10 drug suspects to the United States.

The two men were also blamed for the Nov. 27 bombing of a Colombian domestic jetliner just out-

side Bogota that killed all 107 people aboard.

In October, the government offered \$600,000 for the capture of either of the two men.

Rodriguez Gacha, a billionaire, was a pig farmer before he got into the cocaine business.

Escobar started out in Medellin, Colombia's second city and about 200 miles from Bogota, as a pick-pocket and car thief. Forbes magazine ranks him as being worth an estimated \$2 billion to \$3 billion.

The Medellin cartel together with a smaller, rival group from Cali process about 80 percent of the cocaine sold on U.S. streets, according to American

Meanwhile, in New York, a Colombian drug suspect, who was extradited to the United States yesterday, pleaded not guilty in Manhattan federal court to charges of bringing 244 pounds of cocaine into this

Nelson Cuevas Ramirez, 55, was indicted in November by a Manhattan federal grand jury on three counts of violating U.S. narcotics laws. The charges also include conspiracy to import 330 pounds of co-caine into the United States.

If convicted, he faces a minimum sentence of 10 years in prison on each count and a maximum of a life term. He could also be fined as much as \$4 million on each count.

Cuevas Ramirez, who does not speak English, told a federal magistrate through an interpreter, "I'm not guilty."

Ruth Chamberlin, a court appointed lawyer representing Cuevas Ramirez, said her client agreed to

remain in jail without bail until the next hearing set for Monday.

Cuevas Ramirez was indicted along with Luis Hernando Garces-Restrepo and Jose Jesus Blandon, who both remain as fugitives, the Manhattan U.S. attorney's office said.

A spokeswoman for the Drug Enforcement Administration in New York said the agency has not yet confirmed if the men were associated with a drug cartel. Cuevas Ramirez, a native of Colombia, was

turned over by Colombian authorities to a team from the agency's Special Operations Group Thursday evening in Bogota. He was flown to New York. Colombian President Virgilio Barco reinstituted

extradition to the United States last Aug. 18 as part of a sweeping anti-narcotics offensive against Colom-bia's multibillion-dollar cocaine trade. Cuevas Ramirez was the 10th drug suspect ex-

tradited to the United States from Colombia since

In Colombia, the war between the government and the country's drug lords has escalated with a Dec. 6 truck bomb in Bogota that killed 63 people and the bombing of a jetliner Nov. 27 that killed all 107 people aboard. Barco's administration has blamed drug traffickers for the attacks.

Shore police agencies reap drug-cash dividend

Law enforcement agencies in Ocean and Atlantic counties yesterday were given \$715,000 in cash seized during a drug bust, officials said.

The money was distributed under the "forfeiture" law that gives confiscated drug money and valuables to po-lice agencies to pay for beefed-up enforcement.

The cash was collected earlier this year during the single largest seizure of apparent drug money in Ocean County, Terrence Farley, Ocean County first assistant prosecutor, said yesterday.

Because a criminal case is still pending, the authorities cannot disclose the names of suspects from whom the money was seized, Farley said. However, police did seize \$715,000

in the arrest of two persons in a single

case on Aug. 23.
According to previous Star-Ledger articles, Little Egg Harbor police stopped Christopher Mannery, 32, of Houston, Texas, for speeding on Route

Mannery, who described himself as a self-employed contractor, had a bag in the car which was found to contain \$600,000 in cash.

When police searched his room in the Seaview Country Club, a motel in Galloway Township, Atlantic County, they found an additional \$115,000, according to news reports. They also found 400 pounds of marijuana, with an estimated street value of \$800,000.

Kimberly Ann Fowler, 31, of LaJolla,

Calif., were arrested and charged with conspiracy to distribute a controlled substance

The confiscated money will be distributed according to a formula which rewards extra efforts in drug enforcement, said Farley. "It's absolutely an incentive" to more careful police work,

the first assistant prosecutor said.

The money will go towards the purchase of special equipment such as pclice scanners, Farley said. By law, it cannot be used for salaries or other or-dinary budgetary purposes.

The largest slice of the confiscated money will go to the Little Egg Harbor police department (\$325,000) followed by the Ocean County prosecutor's office (\$225,000) and the Atlantic County prosecutor's office (\$115,000) ecutor's office (\$115,000).

Although a resolution of the criminal charges is still pending, a civil court has upheld the confiscation of the money, Farley said.

The rules of evidence in a criminal case are stricter than in a civil case, making it possible that the civil judgement will stand while criminal charges

The three men "apparently obtained some heroin from an unnamed source and while in Hopewell Township they

in Hopeweii Township, he said. Snell and Haldeman then took Van Fleet to Lambertville police headquarters to seek help, he said.

Authorities are awaiting the results of an autopsy Authorities are awaiting the results of an autopsy scheduled today to determine the cause of death.

"It appears to be drug-related, but we won't know for sure until after the autopsy is completed and the toxicological tests are done," Chipowsky said.

Snell and Haldeman were charged in Lambertville with possession of cocaine, according to Hunterdon County Prosecutor Neil Cooper. Haldeman also was charged with possess-

ion of drug paraphernalia, he said. Snell and Haldeman were being held on \$10,000 bail by Hopewell Township police.
