"She loved Jersey City," Cucci
said. "She really loved Jersey City"

Cucci spoke to a gathering of city employees and reporters in the city council chambers which his wife had decorated with portraits of the city's 36

mayors.

Another reminder of her presence was an illuminated stained glass repro-duction of the city's seal, suspended above the dais. Mrs. Cucci had the century-old artifact restored after rescuing

Mrs. Cucci, 62, was killed Thursday when a tourist tram carrying 11 people derailed and tumbled down an embankment.

The crash happened about six hours after the Cuccis and Councilman Jaime Vazquez arrived in Cuzco to mark the sister-city relationship between the former capital of the Inca Empire and New Jersey's second largest city.

Four men have been detained by authorities in Peru but none has been charged with placing the metal pipe police said was wedged into an expansion in the property of the prope joint and caused the tram to derail

The party on the tram included Mayor Carlos Chacon Galindo, who was critically injured, and his wife, Doris Mayorga Chacon, who was killed.

## Restraint lifted on old house

A Superior Court judge yesterday refused to extend a restraining order preventing the New Jersey Turnpike Authority from demolishing a Civil War-era house in East Brunswick that a group of residents has sought to save.

Judge Erminie Conley, sitting in New Brunswick, also ruled that any advertisement to sell the house must state that the building is at the center of a lawsuit and is being considered for designation as a historic site.

The Turnpike Authority originally purchased the house on Dutch Road to raze it as part of the highway expansion project. Turnpike officials believed that construction activity near the that construction activity near the

house might cause it to collapse. Since June, a group of township residents has fought to save the struc-ture, claiming it represents the style built by immigrants who settled in the East Brunswick-Milltown area. In September, the residents obtained the re-straining order preventing demolition of the house. That order expired yester-

In the meantime, the construction near the house was completed. Turnpike officials now plan to sell the struc-

A state agency is scheduled to decide by Feb. 16 whether the house should be placed on the state historic register. Turnpike officials have said the house probably will not be sold before February.

The residents had requested an ex-

tension of the restraining order because they fear the house will be sold to a construction company that will raze the

Conley left in place a \$25,000 bond the residents had to post to cover the Turnpike Authority's cost of keeping security guards at the house around the clock during the construction activity. Conley has yet to rule on whether the bond will be awarded to the authority or returned to the residents.
