A hatchet-toting Orange man was shot yesterday by police after he became irrational and lunged at an officer

trying to calm him down, authorities reported.

Derrick Jones, 23, of Tremont Place was shot once in the stomach after he struck Sgt. Joseph Pilone four times with a foot-long hatchet, according to Police Director Charles Cobbertt.

Both Pilone and Jones were taken to the hospital.

After being taken to the hospital, the suspect was charged with aggravated assault on a police officer and possession of a weapon for an unlawful purpose, Cobbertt

He noted that Jones will be arraigned at a later date,

after he gets out of the hospital.
Pilone was treated at University Hospital in Newark for cuts to his forehead and right arm. He received 23 stitches to close a wound "over his left eye," Cobbertt

Prior to the incident, the police director noted, authorities had spent nearly 11/2 hours trying to negotiate with Jones, whose mother had called police at 5:10 a.m., saying was causing trouble in the house."

When police arrived, both the mother, Clarida Jones, and her son acknowledged that the son was distraught. He had just returned to the Tremont Place residence from East

Orange General Hospital's crisis center, and he repeatedly stated that he had no intention of returning to the hospital, Cobbertt added.

Police left the home shortly afterwards, with the un derstanding that Derrick Jones would control himself and that his mother would alert police if her son began to act up again, he continued.

At 6:40 a.m., the mother walked into police headquarters on nearby Tremont Avenue and complained that her son "was tearing up the house," Cobbertt said. Eight police officers responded to the scene this time.

They found him in the basement, "acting violent and talking irrational." he continued.

When police tried to approach Jones, Cobbertt quoted the man as telling them, "I'm going to kill anybody who

comes down here. A standoff lasted until 8 a.m., when Pilone told Jones, "Nobody is here to hurt you. We want to help you," Cob-

As Pilone started to descend the basement stairs, Jones suddenly leaped at Pilone, "swinging the hatchet," knocking him backwards, "cutting him over his left eye," inside of his right arm and finally two other times with the back of the hatchet, the police director said.

Officer John Adelizio, while coming to Pilone's aid, "fired one shot, striking Jones in the stomach," according to

Glen Ridge contracts for stump cutter

The Glen Ridge Council last night awarded a \$14,241 contract to Fremgen's Power Equipment Inc. of Midland Park for a power cutter that will be used to remove tree stumps throughout the township.

The cutter was purchased to allow the township to provide its own tree-stump removal service. Mayor Edward Callahan said the township had been using an outside con--tractor and the cost of the service had become too costly.

Callahan added that the new cutter should pay for itself within two years. He estimated that the township can remove 100 trees per year, or 2 percent of the total number of trees

In other business, the council discussed the increasing problem of recruiting ambulance volunteers. Council members said the existing staff is stretched to the limit, due to extensive overtime.

Callahan said the township's public safety is at risk if current conditions continue and the recruitment program falters. He noted it takes, on average, four minutes for a volunteer ambulance crew to answer an emergency call. However, it could take up to 30 minutes or more if the township had to contract with a private ambulance service.

Vincent Bellucio, township administrator, said a lot of effort is put into the volunteer program, with 120 to 140 hours required to train new recruits.

Elizabeth man shot to death in drug 'war'

An Elizabeth man was shot and killed and a girl reportedly wounded last night as a turf war among alleged drug traffickers continued in that city, authorities said.

The 8:15 p.m. shooting of the victim, whose identity

-was not immediately released, and a second unidentified victim described as a "young girl" came hours after authorities announced that a 21-year-old Elizabeth man shot to

death Sunday night was a reputed drug dealer.

After responding to the shooting on Franklin Street last evening, police theorized that the attack was in retaliation to the Sunday violence. Few details were available of last night's incident, they said.

In Sunday's shooting, the dead man was identified as Robert Pretlow, a resident of the Pioneer Homes public housing complex. Police were seeking a suspect in the case.

According to Detective Daniel Geddes, the Sunday incident occurred about 10:45 p.m. on First Street, between Bond Street and Magnolia Avenue. He said police were interviewing witnesses, and have not yet determined the circumstances surrounding Pretlow's death.


The detective said Pretlow recently had been released from jail, where he was being held on drug charges stem-

ming from an incident earlier this year.

Geddes said Pretlow was taken to University Hospital in Newark, where he was pronounced dead about 11:15 p.m. The detective said Pretlow had been shot several times and died of a bullet wound to the head.

The type of gun used in the shooting has not yet been determined.

"There was no altercation prior to the shooting," Geddes said. "What may have happened earlier in the week, I don't know.'

PARKING PROBLEMS East Newark to review handicap spaces

East Newark Mayor John Smith last night sought to ease the concern of handicapped residents whose parking privileges are under review by municipal officials seeking to prevent misuse of the reserved spaces.

There are 12 additional residents who have requested handicap spaces," said Smith. "They feel the special spaces are being abused and were given out in the past for political reasons.

Within 60 days, Smith said, officials will evaluate responses to a questionnaire distributed last night to people seeking the parking privileges at a special hearing as part of the review of the borough's existing nine parking spaces for the handicapped.

"We are trying to do things legal and fair," said the mayor, explaining that officials are required to review the parking privileges every two years under a borough ordinance.

At last night's hearing, Smith told residents that the council will evaluate parking privileges individually and eliminate any for which residents cannot show just cause.

Borough officials will take action after reviewing the questionnaires and medical documentation submitted by holders or seekers of the special parking, Councilman Ed Serafin said. "Those who are entitled will be allowed to keep their spots," he said. 'We will be as fair as possible to these tenants."

Joseph Giunta, 71, of Second Street, later said he feels that officials are handling the matter properly. They should investigate the parking and take it

away if necessary," said Giunta, who became disabled after suffering a stroke. "There are some people who are abusing their space. They don't need it."

parking space. "Sometimes it is hard for me to even walk," said the Third Street resident, stressing that her car is not driven by anyone else. "If they take one space; they should take them all."

Following the hearing, the mayor informed the

council that the Valley National Bank will allow residents to park in its parking lot after business hours beginning next month. The borough will charge users a parking fee, he added.

In addition, the borough is finalizing negotia-

tions with the state Department of Transportation to lease property under the Stickle Bridge for residential parking, according to Smith.

While he said the borough's parking woes are slowly improving, the mayor maintained that offihave a long way to go in providing adequate parking.
